Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

I would like to have the following information in possession of University Hospitals Bristol and Weston NHS Foundation Trust in Microsoft Excel format please:

1. Details (Supplier Name, Type of Service, Value, Expiry Dates) of Contracts the Trust holds with suppliers of transport, courier and delivery services (including taxi services).

We do not have a contract currently with any taxi provider but use a company called Veezu on an ongoing basis after the contract expired in 2021.

The estimated spend for this is £750k although only £80k is on the movement for goods. Our Pharmacy Department has a contract with The Specialist Courier Company Ltd. They provide us with a pharmacy courier service – transport of pharmaceuticals (fridge and ambient). The contract expires 31/03/2025. The value is approximately £120k per annum.

2. Details (Supplier Name, Type of Service, Value, Expiry Dates) of Contracts the Trusts holds with suppliers of logistics, warehousing and off-site storage services.
