For management of acute attacks we use on demand treatments and short or long term prophylaxis medication. Patients have regular follow ups in the paediatrics Immunology Department clinic (every 3-6 months as needed), in Bristol or regional clinics

### 7. What are the main challenges when managing patients with HAE?

Making sure the patients and the families are aware of how to manage acute episodes, when to escalate and liaise with health care professionals/attend the Emergency Department. The main challenges for children are limited treatment options/oral formulations. Most of the medications are currently administered parenterally which can be difficult, especially for children under the age of six.

We underwent the QPIDS accreditation process for the regional paediatric immunology and our service received the QPIDS accreditation in May 2021. We were the third paediatric immunology service ever accredited at that time in the UK.
