Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting
- 1. How many patients were admitted to hospital with pancreatitis in each month of the calendar year 2024?
- 1a) In how many of these cases had the patient been using Semaglutide or Tirzepatide medication such as Wegovy, Ozempic or Mounjaro?
- 2. How many patients were admitted to hospital with pancreatitis in each month of the calendar year 2023?
- 2a) In how many of these cases had the patient been using Semaglutide or Tirzepatide medication such as Wegovy, Ozempic or Mounjaro?
- 3. How many patients were admitted to hospital with pancreatitis in each month of the calendar year 2022?
- 3a) In how many of these cases had the patient been using Semaglutide or Tirzepatide medication such as Wegovy, Ozempic or Mounjaro?

Please include overall cases of pancreatitis, including acute and chronic. Please also include suspected cases of pancreatitis. Please provide a figure for each month of the year requested, rather than the year overall.

Please see our response in the table below, however, we can only provide the total number of patients admitted with pancreatitis. Our systems cannot break this down into patients that have been using weight loss jabs. Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
