Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting
- 1. How many episodes of care were coded by your organisation in 2024 (both inpatient and outpatient)?

Inpatient 177,948 until December 2024. Outpatient 700,048 until December 2024

- 2. How many episodes of care went uncoded in 2024? 16.697
- **3.** How much income do you estimate was not generated due to uncoded activity? £174,211. Please be aware that this estimate was not calculated using the episodes quoted as the detail behind those numbers is no longer available, instead it is based on estimates using activity data we have available to us for 2024.
- 4. Can you provide the split of coding volumes between specialities (e.g., oncology, cardiology)?

Please see the attached document.

5. Please explain how your organisation manages coding activity.

Team of Specialist coders in Bristol and Weston view uncoded report for patient Trust numbers then view and code patient information electronically. Weston codes mainly from paper casenotes but does have a small amount coded from electronic sources. Three team managers are responsible for the staff.

- 6. Are outpatient and inpatient coding managed by the same team or separate teams? Separate
- 7. How many Whole-Time Equivalent (WTE) staff complete clinical coding for the Trust?

8. What proportion of the total WTE staff for clinical coding is substantive (permanent), bank staff, and agency staff?

100% substantive
