Q2. The number of incidents at your NHS Trust where someone aged 65 or over waited 24 hours or longer in A&E from decision to admit to admission in each of the following calendar years:

- A) 2019 - 0**
- B) 2020 - 54**
- C) 2021 - 416**
- D) 2022 - 2176**
- E) 2023 - 524**
- F) 2024 - 310**

Q3. The longest wait at your NHS in A&E from decision to admit to admission in the year 2024.

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from

the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged.
