Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we hold some of the information you are requesting

Q1. How many early-stage (non-metastatic or Stages 1-3) non-small cell lung cancer (NSCLC) patients were treated in the past 3 months with:

- Atezolizumab (Tecentriq): 0
- Durvalumab (Imfinzi): *
- Nivolumab (Opdivo): 8
- Pembrolizumab (Keytruda): 9
- Chemotherapy: *
- **Radiotherapy**: 54 patients had radiotherapy to lung sites; however we are unable to say what the underlying diagnosis is.
- Chemotherapy AND Radiotherapy: 11
- Osimertinib: 0

Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. This follows NHS Digital (formerly HSCIC) analysis guidance (2014) which states that small numbers within local authorities, wards, postcode districts, providers and Trusts may allow identification of patients and should not be published.

Q2. How many patients were treated in the past 3 months for gastric cancer (any stage) with:

- CAPOX (Capecitabine with Oxaliplatin): 7
- FOLFOX (Folinic acid, Fluorouracil and Oxaliplatin): 0

- Lonsurf (Trifluridine tipiracil): 0
- Nivolumab in combination with Platinum (Cisplatin or Oxaliplatin) and Fluoropyrimidine (5-Fluorouracil or Capecitabine): *
- Pembrolizumab in combination with Platinum (Cisplatin or Oxaliplatin) and Fluoropyrimidine (5-Fluorouracil or Capecitabine): *
- Any other systemic anti-cancer therapy: *
- Palliative care only: Our palliative care team have previously advised that they are unable to supply this information on similar FOIs due to the vast number of ways the patient can be referred to palliative care services, some of which bypass UHBW entirely.
- Zolbetuximab (Vyloy): 0

Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. Q3 How many patients were treated in the past 3 months for cancer of the gastrooesophageal junction (any stage) with: This diagnosis is not collected by our e-prescribing system. Given that gastric patients are reported in Q2, we have reported numbers for oesophageal cancer here in Q3.

- FOLFOX (Folinic acid, Fluorouracil and Oxaliplatin): *
- Lonsurf (Trifluridine tipiracil): 0
- Nivolumab in combination with Platinum (Cisplatin or Oxaliplatin) and Fluoropyrimidine (5-Fluorouracil or Capecitabine): *
- Pembrolizumab in combination with Platinum (Cisplatin or Oxaliplatin) and Fluoropyrimidine (5-Fluorouracil or Capecitabine): *
- Zolbetuximab (Vyloy): 0
- Any other systemic anti-cancer therapy: 39
- **Palliative care only**: We do not hold this information due to the vast number of ways patient can be referred to palliative care services, some of which bypass University Hospitals Bristol and Weston NHS Foundation Trust entirely.

Q4 How many patients were treated in the last 3 months with any systemic anti-cancer therapies for Gastric cancer or cancer of the Gastro-Oesophageal Junction? -59

Q5. How many patients has your trust treated in the last 3 months with Pembrolizumab for stage II Melanoma? Using TNM staging: - 0
