- **Omalizumab** - 68
- **Reslizumab** 0
- **Mepolizumab** - 54
- **Tezepelumab** - 23

Q2. Of the patients treated in the last 4 months with any of the above products, please provide the number of patients by the following age-groups:

- **Age 6-11** - 23
- **Age 12-17** - 35
- **Age 18 and above** - 504

Q3. How many patients have been treated in the last 4 months by the Respiratory Medicine department ONLY with:

- **Dupilumab** - 26
- **Omalizumab** - 29

Q4. How many patients have been diagnosed with BOTH chronic sinusitis (ICD-10 code J32) AND nasal polyps (ICD-10 code J33) in the past year? - 132
