Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we hold some of the information you are requesting

This is an information request relating to NHS Trusts buying and supplying Paracetamol and ibuprofen.

Please include the following information for the financial years 2022/23, 2023/24 and 2024/25:

• The total number of individual patients to whom paracetamol and ibuprofen were prescribed by your Trust annually.

We cannot provide this information as we do not have an electronic prescribing system.

• The total amount spent by your Trust on supplying prescribed paracetamol and lbuprofen in each of those financial years.

 We cannot provide this information as we do not have an electronic prescribing system.
- What are the specific conditions which qualify a patient to be prescribed paracetamol

or ibuprofen? Or what is your general policy for qualifying a prescription for paracetamol or ibuprofen?

We prescribe and supply paracetamol or ibuprofen if the patient takes this routinely. We initiate for short-term use in mild acute pain. At discharge we will prescribe and supply if there is a clinical need for ongoing analgesia for mild acute pain; or for regular use if the patient has insufficient supplies at home before the next repeat prescription.

This concludes our response. We trust that you find this helpful, but please do not hesitate to contact us directly if we can be of any further assistance.
