Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

I am writing to submit a Freedom of Information (FOI) request under the Freedom of Information Act 2000. I seek information regarding the provision and commissioning of Vagus Nerve Stimulation (VNS) therapy within your NHS Trust.

- **1. Does your Trust currently provide VNS therapy for patients with epilepsy? -** Yes, for Paediatrics
- 2. Is there a formal contract or service agreement in place for the provision of VNS therapy? No, it is not stated in the service specification from NHSE.

If yes, please provide details on:

- o The type of contract or agreement.
- o Duration and renewal terms.
- o Any key performance indicators (KPIs) or service-level agreements (SLAs) attached to the contract.

3. Does your Trust have a value-based agreement for any neuromodulation services? If so, does this specifically include VNS?

We do not hold this information.

- **4.** How is VNS surgery currently funded, commissioned, and delivered at your Trust? Delivered as part of our elective activity.
- Is it covered under a block contract, an elective tariff (e.g. via the NHS England Specialised Services Devices Programme), or another funding mechanism?

- Does your Trust hold a block contract for Neurology and Neurosurgery services, and if so, does this specifically include epilepsy-related services such as VNS? No
- Are there any existing outsourcing arrangements or public/private partnerships in place for the delivery of VNS surgery or wider epilepsy services? No
- Are there any plans to develop or commission VNS services in 2025/26 as part of the delegated responsibilities to the ICS/ICB for adult patients?

- 5. What OPCS codes does your Trust use for VNS primary implantation and battery replacement of VNS devices? Implantation of VNS A33.1 + Z04.4
- **6.** Are Y codes used for VNS battery replacement surgery? Is the OPCS code YO32 (Renewal of prosthesis in organ NOC) Revision/change of Battery A33.2 +Y03.2. Yes, Y03.2 is used for renewals.
- 7. Has the Y code (YO32 Renewal of prosthesis in organ NOC) been applied consistently for all VNS battery replacement cases in 2023 and 2024? A definitive answer would require a specific audit; however, it is likely that the coding has been applied consistently. Incorporating additional information using Y codes, when supported by documentation, aligns with standard practice.
- 8. Who is the Business Manager for Neurosurgery, Neurology

- **16. What are the current waiting times for patients referred for a VNS implantation and battery replacement?** Average wait for VNS insertion is approximately 11 weeks. Battery replacements are treated as required
- 17. Does your Trust provide VNS services for patients outside its own ICS footprint? If so, how are these services reimbursed? Yes, patients are treated throughout the South West, the service is commissioned by NHSE.
- **18. What is the standard referral pathway for a patient requiring VNS therapy?** Patients are referred to the Children's Epilepsy Surgical Service via their local DGH, assessed and discussed at MDT and then will proceed to VNS if clinically appropriate
- **19. How many VNS implants did the trust implant in 2023 and 2024?** For both primary implants and replacement implants. Per calendar year; 2023 52, 2024 64

- 20. Delegation of Specialised Commissioning Responsibilities
- a) When will specialised commissioning for adult neurology and neurosurgical services, including VNS, be fully delegated to ICBs? Not known
- b) Will paediatric specialised commissioning services also be delegated to ICSs/ICBs? Not known

21. Future Commissioning Responsibilities

a) Will the Department of Health & Social Care assume any commissioning responsibilities for epilepsy and other specialised services for adults and children including VNS surgery? — We do not hold this information.
