Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- **Aromatase Inhibitor as a single agent:** We do not hold this information as this would be prescribed by a GP.

Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged.
