Dear Sir/Madam

Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

- We can confirm that we do hold the information you are requesting
- **For the past 12 months, please provide a breakdown by speciality of the recorded reasons for delays in the commencement of scheduled operating theatre sessions at your Trust's hospitals Sites.**
- **Please include, for each speciality, a summary or categorisation of the reasons for delays (for example: Surgeon Late, Anaesthetist Late, Equipment Un-available, Patient not ready on the ward, etc and, if available, the frequency or proportion of each reason. The total time per delay reason is also required.**
- **If possible, please provide the information in electronic format (such as Excel or CSV).**
- **I understand these are readily available metrics and therefore should not be onerous to provide.**

Please see our response in the attached document. Please note: Where the figures are between 1 and 5, this has been denoted by *. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. This follows NHS Digital (formerly HSCIC) analysis guidance (2014) which states that small numbers within local authorities, wards, postcode districts, providers and Trusts may allow identification of patients and should not be published.

This concludes our response. We trust that you find this helpful, but please do not hesitate to contact us directly if we can be of any further assistance.

If, after that, you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to:
