Q1. How many patients have been treated in the past 3 months with the following agents for melanoma (any stage):

- Cobimetinib: 0

- Dabrafenib + Trametinib: 6
- Dacarbazine: 0

- Encorafenib + Binimetinib: 20
- Ipilimumab monotherapy: *
- Ipilimumab + Nivolumab: *
- Nivolumab monotherapy: 23
- Nivolumab + Relatlimab: *
- Pembrolizumab: 29

- Vemurafenib: 0
- Vemurafenib + Cobimetinib: 0
