Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

We can confirm that we do hold the information you are requesting

### Q1. Please provide the total number of patients treated in the last 6 months for:

- Polycythaemia Vera (ICD10 code D45) 36
- Myelofibrosis (ICD10 code D47.4) 32
- Myelofibrosis (ICD10 code D47.4) patients aged 65 and older 11

### Q2. How many patients were treated in the past 6 months (for any disease) with:

- Ruxolitinib 30
- Fedratinib \*
- Momelotinib 16

Please note: Where the figures are between 1 and 5, this has been denoted by \*. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain. In our view disclosure of these low figures would breach one of the Data Protection Principles set out in Schedule 1 of the Data Protection Act, namely Principle 1. The Trust therefore finds that the Section 40(2) exemption contained within the Freedom of information Act 2000 is engaged. This follows NHS Digital (formerly HSCIC) analysis guidance (2014) which states that small numbers within local authorities, wards, postcode districts, providers and Trusts may allow identification of patients and should not be published.

## Q3. How many patients were treated with Ruxolitinib in the past 6 months for the following diseases?

- Myelofibrosis (ICD10 code D47.4) 9
- Polycythaemia Vera (ICD10 code D45) \*
- Other/Unknown 17

- Of these patients, how many have received no active treatment in the past 6 months?

Q5. Does your trust participate in any clinical trials for the treatment of myelofibrosis? If so, can you please provide the name of each trial along with the number of patients taking part. – Currently one trial is being undertaken – Momentum Extension with \* patients Please note: Where the figures are between 1 and 5, this has been denoted by \*. Due to the low numbers, we have considered that there is the potential for individuals to be identified from the information provided, when considered with other information that may also be in the public domain.
