Thank you for your request for information under the Freedom of Information Act 2000. The Trust's response is as follows:

2. Details of Injuries Sustained, if available:

o Nature of injuries (e.g., fractures, lacerations, concussions).

o Severity of injuries (e.g., minor, moderate, severe).

o Description of injuries.

We are unable to provide this information as our system does not code for pot-hole related incidents. Please note, the Trust does not hold the data in a format that would enable us to fully respond to your request to the level of detail required and a manual trawl for this information would significantly exceed the 18 hours limit set down by the FOI as the reasonable limit. Section 12 of the FOIA provides that we are not obliged to spend in excess of 18 hours in any sixty-day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
