hospital and the trust? This should include expenses related to consultants, secretarial staff, administrative staff, and scanning staff.

In the last 5 years, was there any spending on insourcing or outsourcing of Histopathology services to assist with clearing scans and samples? Please provide details of the total yearly expenditure for these services.

## 6. Managers in Charge of Al and Digital Pathology:

Who are the appropriate managers responsible for implementing Al and digital pathology within the hospital/trust?
